## Bayou Cane Fire Protection District 2021 Budget Message

Date: December 15, 2020

#### **Honorable Commissioners:**

I am pleased to submit a balanced, fiscally conservative proposed budget for **FY2021** for the Bayou Cane Fire Protection District for your review, comment, and action. The proposed 2021 budget is <u>\$5,805,777</u> and represents an <u>\$212,246</u> increase, 3.8%, from the adopted 2020 budget of <u>\$5,593,531</u> with an estimated fund balance of <u>\$1,448,274</u> at the end of FY 2021.

#### RESPONSIBILITIES

"It shall be the mission of the Bayou Cane Fire Protection District to preserve life and property, promote public safety and economic growth through leadership, management, and actions. We will focus our efforts on rapid response to emergencies, providing the appropriate interventions and public education."

The Bayou Cane Fire Protection District has a proud history of serving the citizens of central Terrebonne Parish. We currently possess a Public Protection Grading of "Class 2", and we pride ourselves on providing the ultimate in community involvement and customer service.

Besides the traditional "Fire Protection", we provide on scene emergency medical care with Nationally Registered Emergency Medical Technicians (EMT's). Each of our apparatus is equipped with the proper medical equipment; including Automated External Defibrillators (AED's) and all apparatus are staffed by medically certified personnel.

Our Fire Prevention Bureau promotes a level of safety to the citizens in our district by annually inspecting buildings open to the public to ensure that they are up to code and fire safe. In addition, the bureau strives to educate as many of our citizens as possible on the benefits of fire safety.

# 2020 ACCOMPLISHMENTS: Administration Division

- By far, the greatest accomplishment of BCFD was achieving our PIAL/ISO Class 2 grading!
- Continuously worked to further build upon our working relationships with TPCG offices, surrounding fire departments within the parish, and connect with the community we serve through fire prevention and public education.
- Tested and began researching new and alternate Records Management Systems.
- Began preparation for policy and procedure review and overhaul.
- Entered the research and development phase of budgeting for remodel/upgrades to Central Station.
- Continued computer server upgrades with Fire Dispatch.
- Continued our joint project with Fire Dispatch to integrate the new CAD system and
  to utilize the new system to improve response times and incident information placing
  valuable information directly to the tablets in each truck including pre-plan
  information. Implemented new server and CAD as well as AVL through Fire
  Dispatch.
- Applied for an Assistance to Firefighters grant (AFG) from the USFA.
- Completed the process of upgrading and repairing our training tower (Phase I).
- Completed the replacement project of our stand-by generator at Central.
- Completed a new website along with a new web address: <u>www.bcfire.org</u>.
- Filled all BCFD Board of Commissioner's positions.

# Operations Division

- Formed a committee to field test and evaluate three different types of extrication equipment to replace an aging set.
- Ordered and received new extrication equipment as well as power tool sets for trucks to replace aging drill and saw sets.
- Ordered battery operated K-12 style saw that is compatible with extrication and hand tools. Saw will increase efficiency while expected to decrease fuel and maintenance costs.
- Prepared for and received PIAL Insurance Grade of Class 2 Rating.
- Prepared and implemented Incident Action Plans for COVID-19 Pandemic including employee response and exposure.
- Worked with medical director to develop testing procedure to have employees safely tested, quarantined, and return to work.
- Secured additional PPE for employee and citizen protection during COVID Pandemic.
- Continued responding to medical emergencies with no known direct exposure to employees that resulted in quarantine or loss of work.
- Participated in Parish program providing donated masks to citizens. Handed out approximately 8,000 masks to members of the community.
- Entered the research and development phase of re-structuring physical fitness test, requiring an annual physical fitness test, and budgeting for new work out equipment.
- Purchased a Keiser Sled that allowed for the standardization of agility and fitness testing to replicate more realistic training scenarios.

# Training & Safety Division

#### 2020 Training Division Accomplishments and Statistics

"We believe training does not end when you complete your Recruit Academy but continues until you retire."

- Completed in-house training of 4 new recruits: saving the department more than \$20k dollars on their training.
- Completed in-house Driver/Operator and Aerial/Operator training program for 12 firefighters.
- Hosted training class taught by FD Tactics and Training on Rapidly Developing Leadership and The First Five Minutes.
- Command staff attended "Box Alarm Academy" in Galveston allowing Executive Officers to train together on real world emergencies.
- Began developing a network with St. George Fire Department to send personnel to quality training classes at a better cost to the department.
- Completed an 8 Hour Hazmat Tech Refresher taught by JESTEC
- 2 members completed an 8-hour Hazmat IQ course taught by JESTEC
- 3 members attended a 24-hour LIFT Conference in Baton Rouge
- 1 member attended an 80-hour course on Executive Planning at the National Fire Academy
- 5 members attended the Fall Chief's Symposium
- Completed an initial 40-hour EMR class for 5 members and an additional class for 1 member
- 2 EMT/EMR refresher trainings
- Started an initial EMT Hybrid Course
- Taught 10 CPR classes
- 21 Certifications obtained

- The most significant accomplishment of 2020 was assisting the business owners of our district in navigating all the changes in occupancy limits due to COVID-19.
- Continue to provide timely, efficient, and quality inspections to the residents and business owners within the District.
- Continue our participation in Operation Save -A- Life by providing smoke alarms to the residents that request and qualify for them.
- Continue to further promote the department via social media and Fire Prevention Bureau webpage.
- Continue our close working relationships with TPCG Permits, TPSO Detectives, LSFM Office, and surrounding fire departments within the parish.

#### BCFD Goals for 2021

- Continue to provide timely, efficient, and quality responses to requests for assistance from the residents of Bayou Cane by maintaining a sufficient number of trained Firefighters/E.M.T. and officers.
- Continue saving and planning for the purchase of a Class-A burn building in an effort to achieve a state-of-the-art training facility.
- Devise a long-range budget plan that will address community needs as well as the needs of the department.
- Continue to update and maintain the department's IT and computer systems.
- Continue to provide quality in-house training to members while working to improve cost saving measures as it relates to training.
- Continue to assist members as a resource to continue growth in special operations.
- Reapply for Fire Act grant from FEMA for portable radios and headsets for apparatus.
- Purchase exercise equipment at all four stations to promote physical fitness throughout the department.
- Renovate the living quarter side of Central Station.
- Complete concrete repairs as needed at Central station.
- Began phased upgrade plan for the department's radio communication system
- Research additional and alternative means of funding for the department.
- Work with the District Board of Commissioners, as well as community stakeholders and partners, to devise a funding initiative that will stabilize the current department operational expenses, upgrade our training facility, strategically cover the district commensurate with its growth, and provide funding for future growth and expansion.

•	Continue to work with our Medical Director to ensure employee safety in response to the COVID-19 pandemic
•	Renew our current millage of 20 mills.

#### Conclusion

Every line item and category of the budget was highly scrutinized. With the development of a 10-year capital outlay plan, we have begun to reasonably plan for the future. Due to spending and budgeting practices incorporated in 2013, we were able to adequately replace aging bunker gear, SCBA cylinders, and begin to replace our aging fleet.

As you are all aware, 2020 has been a strange and trying year to say the least. From the COVID-19 pandemic, that has not only affected our country but our state and district, to what seemed like a weekly hurricane drill. In emergency services, we usually approach an incident in three phases: the planning, operational, and recovery phases. With the COVID-19 pandemic, we have had an operational phase that has spanned from March 2020 that is still ongoing. BCFD is handling this response very well. We initially saw an increase in call volume, a mad dash to secure PPE and supplies, to a plateau in calls for service. We handled the "first wave" with very little infections. In the second wave we were not so lucky. All total, we had 15 members of the department who were positive for COVID. Fortunately, we did not see a decrease in manpower as the cases were spread to a manageable incident. We continue to stand at the ready should the number of cases rise again. As the pandemic hit our district, we set out to implement Standard Operating Procedures and Guidelines that were "living" documents. As CDC guidelines changed, our procedures were reviewed and revised to remain current. Several changes to how we operated and staffed the department were also implemented. All of our objectives were achieved with little to no interruption in service. We, like so many others, worked from home, used virtual, meetings, and learned how to live in the "new" normal. If an additional wave of COVID should arrive, we are fully prepared to handle and respond to it.

During the pandemic, along came hurricane season. BCFD activated our hurricane response plan three times and were on the verge of activation four additional times as our district had the potential of being affected by a tropical storm or hurricane seven times. We double shifted when needed and stood ready to respond to an increase in calls related to the storms. The 2020 season has made us realize that our hurricane policy needs additional tweaking and upgrades consisting of response procedure, hazard pay, and additional resources. The administrative staff will ensure our policies are updated and we will be attending additional classes regarding FEMA policy and reimbursement procedures prior to the start of the 2021 hurricane season.

We have a top-notch department that I know each of you are extremely proud of. We have diligently worked to ensure partnerships with local, state, and federal agencies. None of this could be possible without the hard work and dedication from our staff that includes probationary firefighters, experienced company officers, seasoned chief officers, qualified and competent division chiefs, and YOU.

In summary, the entire department has accomplished unity as a well working team. This is the biggest accomplishment we have been working towards for several years. Our employees come to work with a new sense of pride. We have reached this goal with aggressive training, coaching from the administration, and positive reinforcement. This accomplishment is what gives Bayou Cane the professional image that you and our community can be proud of.
