#### August 8, 2022

There were four major commercial renovations. There were 1133 YTD inspections. The 2% fire insurance rebate was received in the amount of \$168,199. The debt for the two trucks has been paid off.

Suzanne Carlos complimented everyone on a speedy arrival with an incident that happened where a vehicle fell on someone. Robert Page asked for a CBDG loan update.
